Thereafter the floor was handed over to Mr. Muhammad Kashif Riaz, Member Executive Committee/Chairman of Expo-2022 Committee to apprise the House about its pros and cons. In his address, Mr. Muhammad Kashif Riaz apprised the House that the issue with regards to holding the Expo in indoor or outdoor remained the burning point for so many days. He disclosed that as per consensus of the stakeholders, the Expo was scheduled from 25th to 27th March, 2022 but both the Marquees namely R.A. K as well as Crystal earmarked for the purpose regretted to accommodate us anyway. Now the 2nd option remains for outdoor which was in principle agreed upon after very exhaustive deliberations. The House requested the President, SCCI to see the District Sports Officer and Deputy Commissioner, Sahiwal for the allocation of suitable ground like Zafar Stadium, Hockey Ground or Football Ground for the purpose. The House also finally gave green signal to the Expo Committee to go ahead and take all possible measures to ensure that the Expo-22 is organized on the above dates positively in a phased manner.

5. Any other point with the approval of the Chair

Managing of Medical Camp for Laboratory Tests

The President apprised the House that one day's Medical Camp for free Laboratory Tests is going to be arranged in the premises of the Chamber or any other suitable place to be notified with the courtesy of Al-Falah Diagnostic Lab on 6th March, 2022 right from 9 am onward. The idea was lauded by the House with the request to give wide publicity to this Event so that maximum number of deserving people could be benefitted. Mr.Muhammad Afzal Kashif, Member EC was assigned the responsibility to manage it by all means which he accepted whole heartedly.
